Reservations are available for Riverside Swim Club Members. Rentals are available Friday - Sunday and reservations are accepted up to 90 days in advance of your event.

Rentals available for: birthday parties, family celebrations, bridal/baby showers, group meetings, retirement parties, holiday parties, etc.

- Great room: Fireplace, flat screen Smart TV, Shuffleboard, tables & chairs to seat 46.
- Kitchen: Refrigerator, freezer, microwave, ice machine & countertop access.
- Outdoor raised deck: Fireplace, grill, tables & chairs. Seating for 50 (not available November - March.)
- General: Wi-Fi, air conditioning & central heating. Access to sound system for music. Clubhouse rental facility capacity is 150.

General Information



A Form to reserve the facility is available on our website. You must be 21 years of age, and receive approval by the management team based on availability. Only RSC members are allowed to reserve this space. A rental is not complete, and your date request is not guaranteed, until all fees are paid in full, all forms are turned in, and the rental agreement is approved by the RSC management team.

- All renters must be cognizant of sound ordinances and our Riverside neighbors.
- While a grill is available for your use, you must provide all materials and are responsible for the cleanup.
- A security deposit will not be charged, but RSC reserves the right to charge for any damages incurred during facility rental.
- Renters must leave the facility as they found it, including location of furniture.
- Requests must be made at least 7 days prior to event date.
- Cancellation within 7 days of rental results in a \$100 fee to cover staffing costs associated with rental.

Friday: 4pm-11pm Saturday: 10am - 3pm / 4pm - 11pm Sunday: 10am - 3pm / 4pm - 10pm

\$350 for a 2-hour rental slot. You may purchase up to 3-4 additional hours at\$50 per hour. Additional \$100 charge if alcohol allowed.

- 5) Facility must be returned to the condition in which they were found.
- Requests must be made at least 7 days prior to event date. 6)
- Cancellation within 7 days of rental results in a \$100 fee to cover staffing costs associated with rental. 7)
- Rental fee includes one facility walk-through. Additional walk-throughs are \$25 each to cover staffing costs. 8)
- 9) Events more than 100 people may incur additional charges if staffing / cleaning needs are increased.
